DESCRIPTION:

Floor Grip is a non-slip, non-skid alkyd aggregate coating for steel, aluminum and masonry surfaces. It contains a special aggregate combination which withstands rough weather conditions and daily wear and tear.

RECOMMENDED USES:

Floor Grip is for use on steel, aluminum or concrete masonry surfaces such as; decks, porches, walkways, ramps, steps, boat decks, bridgeways and numerous other industrial applications. NOT FOR USE ON WOOD SURFACES. For wood surfaces use **Farwest Deck Safe** (2001 Series).

SURFACE PREPARATION:

Clean all surfaces of oil, dirt, grease, corrosion and any existing paint that lacks good adhesion. Temperature must be a minimum of 50°F to apply Floor Grip. Steel, aluminum and masonry should be etched with Farwest 695 Rynolite Chemical Cleaner-Etcher. For optimum adhesion a primer should also be applied. Prime aluminum surfaces using a fog coat of **Zinc Chromate Wash Primer.** Prime steel surfaces using **Farwest Lacquer Proof Primer.**

COVERAGE: 75 sq. ft. per gallon.

THINNING: Thinning is not recommended. If absolutely necessary use 605 Synthetic Thinner.

APPLICATION: Stir thoroughly. Apply by brush or roller.

CLEAN-UP: Equipment and tools may be cleaned with 605 Synthetic Thinner or 610 Lacquer

Thinner.

DRY TIME:

Dry to touch in 1 hour. Tack free in 2 hours. Recoat in 8 hours. Dries hard in 8 hours.

CAUTIONS:

DISPOSAL OF OILY RAGS: Rags and other waste materials soiled with this product may spontaneously catch fire if improperly discarded. Soak soiled rags and waste immediately after use in a water-filled, closed metal container.
